**NOW THIS TRUST DEED WITNESSETH AS FOLLOWS:**

**1. Declaration**

That, in order to effectuate his aforesaid desire, the Author of the Trust hereby declared that, he has irrevocably settled an amount of Rs.99,999/- (Rupees Ninety nine thousand nine hundred ninety nine only), hereinafter called the TRUST FUND, by Cheque No.242155, dated: 06-04-2021 drawn on State Bank of India, Kavuri Hills Branch, to be deposited in the name of the Trust herein after mentioned for the sole purpose that it should form the nucleus and corpus fund for the foresaid trust and that the undersigned has accepted the said cheque in his capacity as a first trustee, subject to the condition hereinafter stated.

**2. Name**


That the name of the trust shall be **SAMATVA EDUCATION TRUST** and its office shall for the present be situated at House No.8-2-248/1/7/41, 41/1 to 8, Nagarjuna Nagar, Panjagutta, Banjara Hills, Hyderabad-500082, Telangana and/or at such other place or places as the trustees may decide from time to time.

**3. Duration of the Trust**

This Trust and the Trust Fund shall be irrevocable for all times and will continue in perpetuity.

#### 4. Objects

That the OBJECTS for which this trust is established are:

- a. To establish, aid, administer and maintain schools, colleges and other institutions for Primary, Upper Primary, Secondary, Intermediate and Degree students.
- b. To establish, aid, administer and maintain educational institutions for primary, General, Technical and Managerial education.
- c. To establish, aid, administer and maintain technical educational institutions such as Technical, Engineering, Medical and Pharmacy colleges and institutions.
- d. To establish, aid, administer and maintain Management educational institutions such as Business and other management colleges and institutions.
- e. To establish or support aid and administer sports and games clubs like Gyms, Yoga Swimming pools and organize or undertake the establishment of workshops to better their skills and health conditions.
- f. To give scholarships, awards (both in cash and in kind) to merit students of primary, secondary and intermediate education basing on the merit of the students in their respective examinations conducted by respective education boards or other modes selected by the Trust.
- g. To establish, aid and maintain hostels for the students of the educational institutions established, aided and maintained by the trust.
- h. To establish workshops, training facilities and to impart practical training in General, Technical, Engineering and management skills and provide and create means of finance to help the students and trainees to further their training and education levels.
- i. To carry on activities for any other charitable and educational purposes and activities of general public utility.
- j. To run and maintain libraries and reading rooms.

- k. To advertise or give publicity, in order to encourage public to use the utilities provided by the Trust in order to propagate the above objectives of the Trust.
- l. To enter into alliance with co-operate or affiliate to such bodies and organisations that work with similar objectives or that may help the advancement of the objectives of the Trust.
- m. To enter into or undertake such other transactions, contracts or other activities as are conducive for the attainment of above objectives of the Trust.

**5. Fund**

That the trust fund may be augmented from the income from initial trust fund i.e., the cheque handed over by the Author of the Trust, the income of the trust and also by donations and other contributions received by the Trust from time to time.

**6. Application of Funds**

That the trust fund shall not be applied for any other purpose than those specified in Para 4 herein above.


Without prejudice to the generality of the powers vested in the Members of the Trust and notwithstanding anything in the Trust Act, the funds of the Trust shall be invested in accordance with the provisions of Section 13(1)(d) read with section 11(5) of the Income Tax Act or any other provisions applicable from time to time.

**7. First Trustee(s)**

The author of the Trust Sri Alluri Raghu Varma will be the First Trustee and also the First Managing Trustee for life and Sri Sanjay Varma Vatsavai shall be the trustee. The Managing Trustee will have the right to co-opt any other person(s) as co-trustee(s) during his life time.

**Board of Trustees**

The First Trustee with the other trustees will form the Board of Trustees to administer the objects of the Trust. The affairs of the trust shall be managed by the Board of Trustees. The number of trustees shall not be less than 2 or more than 7. If the number of the trustees shall fall below 2, the trustees shall not except for the purpose of filling any vacancy, act so long assure number is below the said minimum.

**8. Managing Trustee:**

The Managing Trustee shall be at liberty to appoint additional trustee or trustees within the number mentioned above for such period or on such terms as to retirement and re-appointment as the trustees for the administration of the Trust.


**9. Trustees Tenure:**

A person shall cease to be a trustee either:

- (i) If he/she is requested to resign by 3/4<sup>th</sup> or as near thereto as possible of the remaining trustees.
- (ii) If he/she suspended by the Managing Trustee.
- (iii) First Trustee or Trustees appointed for their life time, the above clause (i) will not apply unless they resign voluntarily.
- (iv) The First Trustee/ Managing Trustee is at liberty to appoint Trustees for life time. Managing Trustee can also resign on giving one month's notice, further, every trustee is at liberty to resign on giving one month's notice of his/her intention to do so. In the event of Managing Trustee resigns, the remaining Trustees shall elect the Managing Trustee amongst themselves, for the period as decided by them.

**11. Accounts:**

That the trustees shall always maintain proper accounts of the Trust which shall be kept at the office of the Trust. The accounts of the Trust shall be closed at the end of each financial year and shall be audited by a Chartered Accountant (as defined in Chartered Accountants Act, 1949) appointed by the trustees every year.

**12. Trustees Powers :**

That for the furtherance of the objects of the trust, the trustees shall have the following powers:

- i. To accept donations, contributions, grants or subscriptions, in cash or in kind, from any person(s), body of persons or trusts, companies, firms, Government Departments, etc., with or without conditions.
- ii. To apply the whole or any part of the income of the trust, or the trust fund or accumulations thereto, to any one or more of the objects of the trust, as the trustees may, in their discretion, deem fit from time to time.
- iii. To convert and deal with the trust property and/or any investments of the trust for the time being.
- iv. To let out any immovable property comprised in the Trust fund for such period and at such rent on such terms and conditions as the trustees in their discretion may think fit.
- v. To open account in the name of the Trust with a Bank or Banks, to operate such account and to give instructions to the Bank(s) and to provide for opening and operation of such account by one or more of the Trustees or by an agent or power of attorneyholder appointed by the Trustees.
- vi. To adjust, settle, compromise, compound and refer to arbitration all actions, suits, claims, demands and proceedings regarding the trust fund.
- vii. To appoint constituted attorneys or agents and to delegate to such attorneys or agents all or any of the powers vested on them under these presents and from time to time remove such attorneys or agents and to appoint other or others in his or their place.

- viii. To appoint or make provision for the appointment of any person (including all or any of the trustees and committees or administrator or Managing Trustees or otherwise) for the purpose of the administration of the Trust in such manner and subject to such rules and regulations as the Trustees may prescribe and also to appoint or provide for the appointment of separate Trustees to hold any fund or investment subject to the provisions of this deed in such manner and subject to such rules and regulations as the Trustees may from time to time think fit.
- ix. To make, vary, alter or modify schemes, rules and regulations for carrying out the objects of the Trust and for the management of the affairs thereof and /or running any institution in furtherance of the objects of the Trust and otherwise of giving effect to the objects of the Trust.
- x. To set apart and/or allocate the whole or a part of the income or the corpus of the Trust fund or part thereof for any of the objects of the Trust.
- xi. To give aid by way of donations, out of the income or the corpus of the Trust Fund or otherwise, to different charitable institutions, societies, organisations or Trusts in India, which may have been established or which may hereafter be established for the like charitable purposes mentioned in these presents or any of them to enable such institutions, Societies, organisations or trusts to start, maintain, or carry out such charitable objects.
- xii. To settle all accounts and to compromise, compound, abandon, or refer to arbitration any action or proceedings or disputes, claim, demand or things as deemed proper for such purpose without being responsible for any loss occasioned thereby.

- xiii. To apply to Government, public bodies, urban, local municipal, district and other bodies, corporations, companies or persons for and to accept grant of money and of aid, donations, gifts, subscriptions, and other assistance with a view to promoting the objects of the Trust and to discuss and negotiate with the Government departments, public and other bodies corporations, companies or persons, schemes and other works and matters within the objects of the Trust and to conform to any proper conditions upon which such grants and other payment may be made.
- xiv. To take over, acquire, manage, control or aid any existing institution or institutions having objects either wholly or in part similar to the objects of this trust and on such terms and conditions as may be thought expedient.
- xv. To establish, promote, manage, organise or maintain or to assist in establishing, promoting, managing, organizing, any branch of the trust or any other trust or its branch with objects similar to those of this trust and to promote or carry on the affiliation or amalgamation of such other trust with this trust.
- xvi. To purchase or otherwise acquire and undertake all or any part of the property, assets, liabilities and engagement of any one or more of the trusts, societies, institutions or associations those which are taken over by this trust.
- xvii. To purchase or otherwise acquire and undertake property assets and other movable and immovable properties in the name of the trust as decided by the trustees as per their discretion.
- xviii. To enter into all types of agreements with individual, trusts, association of persons, bodies corporate, firms and others for the management of the trust and for the attainment of the objects of the trust.
- xix. To borrow money, raise loans from persons, financial institutions, banks other lending organisations for the attainment of objects of the trust and for borrowing money or raising loans, pledge or hypothecate the property of the Trust.

- xx. All the investment of trust funds in the nature of deposit of liquid funds shall be deposited by the trustees only in the manner prescribed as per the provisions of Section 11(5) of the Income Tax Act.
- xxi. The trustees shall have the power to determine in case of doubt whether any moneys or property shall for the purpose of the charity be considered as capital or income and whether out of income or capital any expenses or out goings ought to be paid or borne and every such determination shall be binding and conclusive provided that nothing contained shall be deemed to authorise the trustees to spend the income or corpus of the Trust for any purpose not authorised by these presents.

### 13. Accountability

The trustees shall be accountable only for such money, stocks and funds as shall actually come into their hands and a trustee shall not be answerable or accountable for neglect, default, acts of omission or commission of the other trustees, nor of any banker or other person with whom the trust properties or any security have been deposited or kept.


### 14. Role of Trustees

The trustees will not be entitled to receive any remuneration, but the trustees may reimburse themselves all expenses actually incurred by them in connection with the trust or their duties relating thereto.

### 15. Meetings :

The trustees shall from time to time frame rules for the conduct and regulations of the meetings of the trustees. In the absence of such regulations:-

- i. Two trustees shall form a quorum for a meeting of trustees.
- ii. All matters will be decided mutually by the trustees.
- iii. Resolution passed without any meeting of the trustees but by circulation thereof and evidenced in writing under the hands of Managing Trustee shall be as valid and effectual as a resolution passed at a meeting of trustees.
- iv. The trustees shall conduct at least ONE meeting of trustees in a calendar year.

**16. Alteration:**

If the trustees are desirous of altering, changing, modifying, deleting or adding any clause or clauses of their Trust Deed, they shall do so, AS PER THE PROVISIONS OF THE INDIAN TRUST ACT, with the prior approval of the COMMISSIONER OF INCOME TAX, having jurisdiction over the trust and by following necessary procedures prescribed by the Indian Trust Act.

**17. Winding-up :**

To transfer or hand over the trust to any other trust, society, institution or organization in case of winding up of this trust the trustees shall transfer all the assets of the trust remaining after clearing off its debts. The trustees shall do so with the prior approval of the COMMISSIONER OF INCOME TAX having jurisdiction over the trust and on such terms and conditions the COMMISSIONER OF INCOME TAX shall impose and the transfer of the assets shall be done as mentioned above, only to the trusts, societies, institutions or organisations having similar objects as that of this trust and which are having registration U/s 12A of the Income Tax Act and the properties handed over as stated above to other trust(s), Society(s), Institution(s) or Organization(s) shall bear the name of this trust and shall be maintained as a separate entity by the absorbing trust.

**18. Declaration:**

It is expressly declared that no part of the trust property or its income or any accretion there to shall be distributed among the members of the trust either directly or indirectly by way of profit or dividend or otherwise and further the benefits of the trust are open to all irrespective of caste, creed, sex, community, religion etc., and further the activities of the trust shall be charitable in nature and should be confined to India only and no activity of the trust shall be carried any where outside India.

19. No immovable properties are involved in the Trust as on the date of Registration.
